

Privacy Policy

Hasche Limited ("we", "us", "our") is committed to protecting and respecting your privacy. This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

1. Information We Collect From You

We may collect and process the following data about you:

- **Information you give us:** This is information about you that you give us by filling in forms on our site hasche-consuling.ie or by corresponding with us by phone, e-mail or otherwise. It includes information you provide when you register to use our site, subscribe to our service, search for a product, place an order on our site, participate in discussion boards or other social media functions on our site, enter a competition, promotion or survey, and when you report a problem with our site. The information you give us may include your name, address, e-mail address and phone number, financial and credit card information.
- **Information we collect about you:** With regard to each of your visits to our site we will automatically collect the following information:
 - **Technical information**, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform.
 - **Information about your visit**, including the full Uniform Resource Locators (URL) click stream to, through and from our site (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.

- **Information we receive from other sources:** This is information we receive about you if you use any of the other websites we operate or the other services we provide.
 - **Information others receive:** Our website is hosted by the external provider Ionos SE (Germany). When you visit our website, our hosting provider automatically processes certain technical data necessary for the provision and security of the website. This may include: Your IP address, Date and time of access, Browser type and version, Operating system, Referrer URL. These server log files are processed solely for technical purposes, to maintain server stability, and to defend against attacks. No personal analysis or disclosure to third parties takes place.

2. Cookies

3. Legal Basis and Purposes for Processing

We process your personal data based on the following legal grounds under GDPR:

- **Consent (Art. 6(1)(a) GDPR):** Where you have given us your consent to process your personal data for a specific purpose (e.g., for marketing emails).
- **Performance of a Contract (Art. (1)(b) GDPR):** Where processing is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into a contract.
- **Legal Obligation (Art. (1)(c) GDPR):** Where processing is necessary for compliance with a legal obligation to which we are subject.
- **Legitimate Interests (Art. (1)(f) GDPR):** Where processing is necessary for the purposes of our legitimate interests or those of a third party, except where such interests are overridden by your interests or fundamental rights and freedoms.

We use information held about you in the following ways: * To carry out our obligations arising from any contracts entered into between you and us. * To provide you with the information, products and services that you request from us. * To provide you with information about other goods and services we offer that are similar to those that you

have already purchased or inquired about (only with your consent). * To administer our site and for internal operations, including troubleshooting, data analysis, and testing. * To improve our site to ensure that content is presented in the most effective manner for you and for your computer.

4. Disclosure of Your Information

We may share your personal information with selected third parties including: * Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you. * Analytics and search engine providers that assist us in the improvement and optimization of our site. * Credit reference agencies for the purpose of assessing your credit score where this is a condition of us entering into a contract with you.

We will disclose your personal information to third parties if we are under a duty to do so to comply with any legal obligation, or in the event that we sell or buy any business or assets.

5. International Data Transfers

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

6. Your Rights as a Data Subject

Under the GDPR, you have several rights in relation to your personal data. You have the right to: * Access: You have the right to request a copy of the information that we hold about you. * Rectification: You have a right to correct data that we hold about you that is inaccurate or incomplete. * Erasure ("Right to be Forgotten"): In certain circumstances, you can ask for the data we hold about you to be erased from our records. * Restriction of

Processing: Where certain conditions apply, you have a right to restrict the processing. * Data Portability: You have the right to have the data we hold about you transferred to another organization. * Object: You have the right to object to certain types of processing such as direct marketing.

7. Data Security

We have put in place appropriate technical and organizational measures to protect your personal data from accidental loss and from unauthorized access, use, alteration, or disclosure. All information you provide to us is stored on our secure servers.

We will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.
